INTRODUCTION

Known for its multicultural diversity, many have not known that Indonesia implement three different legal system in its society. Indonesia adheres to three legal systems at once that live and develop in the life of society and the state administration, namely the civil law system, the customary law system, and the Islamic law system. The civil law system which has the character of "written law" developed in Indonesia during the Dutch colonial period and has persisted to this day, influencing applicable legal products. Then, customary law as the original law that grows and develops from the habits of the community with a large and varied number, greatly affects the process of enactment of law in Indonesia. In addition, Islamic law also influences the legal system in Indonesia because the majority of the population in Indonesia adheres to Islam, which allows Islamic law to become an important and influential part of the legal system in Indonesia. In this course, the participants will be introduced to the Indonesian legal system, which recognizes and applies the mixed legal system, namely continental law, customary law and Islamic law in the Indonesian legal system. This course is an academic collaboration between Law Department and Pancasila and Civic Education Department of Universitas Ahmad Dahlan (UAD). The credit for this course is equivalent to 3 credits. The running of the course will be held using e-learning platform provided by (elearning.uad.ac.id) and zoom for virtual meeting.
